CALL TO ORDER (David Farnsworth)

Welcome and Introductions

APPROVAL OF AGENDA

Rosella moved to accept the agenda. Dr Mark Hagerott seconded. All in favor.

APPROVAL OF MINUTES

Dave Kemnitz moved to approve the July 27, 2016 minutes. Dan Leingang seconded. All in favor.

Directors Report (Susan Gunsch)

- Budget & Membership update
 - One Stop MOU signed and available on jobsnd.com. It will require modifications to be in affect by 2017
 - Federal final regulations were released and were posted on August 19. The preamble indicates further guidance will be coming. It looks like the need for an RFP is still in place for procurement of the One Stop Operator, coordination of services and delivery of all of the programs.
- Update on Apprenticeship/Workforce Strategy RFP
 - Apprenticeship Accelerator grant
 Three proposals were received for expanding manufacturing, energy, IT and health care in North
 Dakota. Specifically, the award grantee will be tasked to build Registered Apprenticeships within
 the four areas, establish boot camps, match credentials earned at the end of training, and work
 with community colleges to expand curriculum for apprenticeship training. The initiative will run
 through May 2018 and will promote and establish a brand for registered apprenticeship within ND.
- Unified State Plan is approved (will require revisions by July 1, 2018)
- Eligible Training Provider (ETP) List demonstration (Tammy Barstad)

- Vocational Rehabilitation (Brenda Vennes)
 - Reviewed Applicants, Plans and Employed report
 - Department of Commerce, Workforce Development Division (Wayde Sick)
 - Workforce Enhancement grants update, approved 4 grants to educational institutions (TrainND)
 - Remaining balance just above \$600,000. Two institutions are planning to apply for a couple of grants that will likely take the rest of the funds.
 - Early childhood grant has 44 programs approved, most in the rural areas.
 - Governor's Workforce & HR conference 2016 was the largest conference so far with 480 people in attendance on the first day. Next year's conference is set for September 20-22 2017 in Fargo.
 - Educators in Industry grant externships for teachers is moving forward for another session, information will be released in the spring.

Committee on Employment of People with Disabilities (Bruce Murry)

Contracted with Minot State University to survey the status of employment of people with developmental
disabilities. 67% working for pay (improved from 64% in 2012). The survey showed more progress with
people who have more disabilities than those with fewer disabilities. Those unemployed aren't interested in
working or are having difficulty finding work that interests them or that works with their skills. Those with
mental health and brain injured individuals showed lower for employment. Bruce will share a link with to
access the report.

Working Lunch -

General Equipment & Supplies (Don Schilling, President/Ann Pollert, Recruiter)

- The diesel technology industry recognized a future shortage in construction equipment maintenance industry. The Associated Equipment Distributors established the AED Foundation (national organization of 750 members strong) for workforce development and education/training. The foundation established standards for diesel technology (standards revisited every 3 years) and worked with schools to implement training programs, there are currently 39 accredited programs, including one at NDSCS. Students are assessed to identify skill levels at entry and exit of programs to measure how well institution is teaching to the standards. There is a 5 year reaccreditation process for educational institutions. Partnerships that make these programs possible are with manufacturers, technical colleges, and dealerships. Sponsored students who complete the program earn a 2 year associate degree, get tuition reimbursement, are debt free 3 years after graduation, are provided industry jobs while attending school, and have a fast track for career advancement.
- Seeking assistance from the Workforce Development Council for assistance with barriers local school
 cooperation, need to be able to go into local high schools (several won't allow private industry to come in
 to the school), need access to the graduates and parents, able to reach less than 10% of guidance
 counselors through NDSCS outreach, public awareness of program and partnerships.

NDSCS (Dr. John Richman, President)

- Reviewed NDSCS brochures in packet
- As a Council, to be effective for industry, things need to change at the policy level within legislation for tuition-free programs that prepare students for in-demand occupations struggling to fulfill workforce needs. Colorado implemented a program 6 years ago, Tech Prep Build. If business and industry come together to collaborate with a public school, they all benefit, the state funds it. Twelve states have implemented programs of this type.

Nursing Supply and Demand Chartbook (Dr. Patricia Moulton, North Dakota Center for Nursing)
Presented 2016 ND Nursing Education Supply and Demand Chartbooks. The ND Board of Nursing started a longitudinal study tracking supply and demand in 2002.

Member updates and July meeting topics revisited

- Workforce Retreat and update on coal industry.
- Infrastructure construction building within ND will likely be impacted by political decisions, may deter further work of this type within the state.
- Manufacturing is slow, don't expect the industry to increase until 2nd half of 2017.

- Strata just acquired Mariner Construction, Steffes steady and diversified.
- Oil fields very busy, not having an issue finding a workforce, about 10% coming back from unemployment (most don't want to go back).
- Power industry, price of electricity is about 40% less than it was a few years ago, wind energy has generated a
 lot of electricity without a direct need. Uncertainty within the industry is causing a move to use more natural
 gas rather than coal. Mandates and tax credits are in place to use renewable energy. Large demand for coal
 around the world, China uses more than they can produce; however, the environmental solutions don't allow
 for compromise. Expect the expansion of renewables to continue.
- Susan Gunsch for Valerie Fischer WIOA regulations require representatives of this WDC board to review the
 proposals and make recommendations. The bidders' conference is set for December 14. New contracts will
 start July 1, 2017. Nationally, Adult Education is moving to regional areas rather than local areas.
